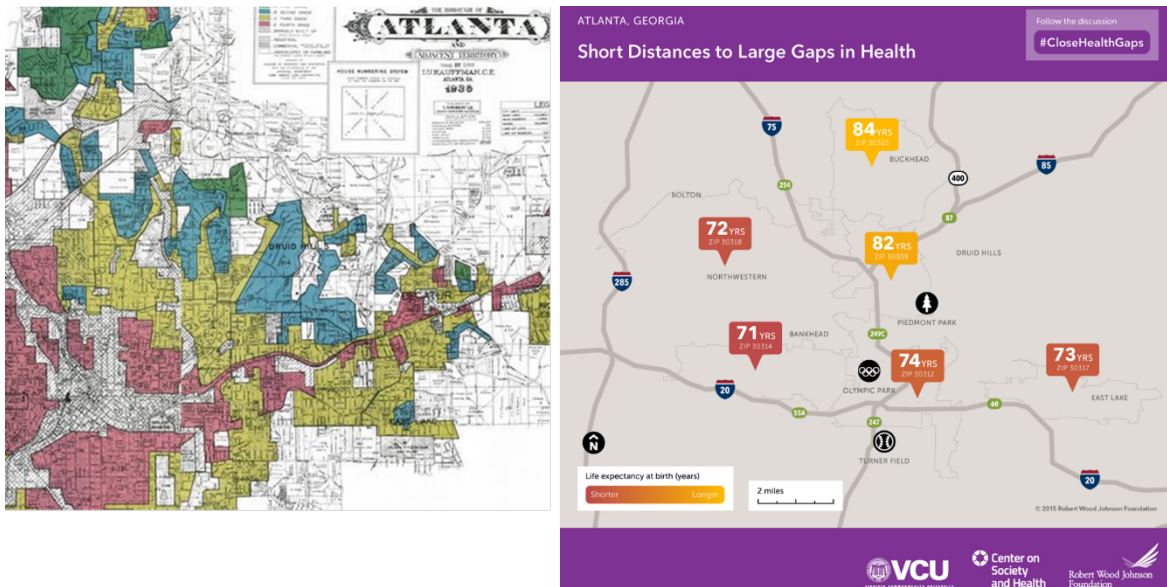




ARCHI Quarterly Breakfast Summary March 7, 2018

ARCHI heard from many of our partners requesting the slide shared by Natalie Burke which overlaid the Atlanta redlining map with life expectancy data, highlighting the inequities that are seen in too many of Atlanta's communities (image below). The interest in the topic helped shape our agenda for the meeting.

- Dr. Elizabeth Ford, Director of the DeKalb County Board of Health and ARCHI Steering Committee Member, welcomed meeting attendees, reviewed the agenda, shared the ARCHI 2017 year-in-review, and invited first time attendees to introduce themselves.
- An informed panel presented the critical issues that our state legislature is discussing this session that will impact ARCHI's 28-year strategy. The panel helped frame how strategic policies and programs can advance ARCHI's priorities. The panel was moderated by Dr. Karen Minyard, CEO of the Georgia Health Policy Center and Steering Committee member and the panelists included:

- Dr. Dan Immergluck, a renowned Professor in the Urban Studies Institute at Georgia State University, gave an overview of the history of redlining, its legacy, and the disproportionate effect of subprime and predatory lending in the most recent housing crisis. Dr. Immergluck's presentation concluded with policy recommendations to address the effects of these policies and avoid new approaches seeking to continue a legacy of housing discrimination.
